NOTICE OF RACE

1 RULES

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.

2 ADVERTISING

2.1 Competitor advertising is unrestricted

2.2 Boats may be required to display advertising chosen and supplied by the organizing authority.

3 ELIGIBILITY AND ENTRY

3.1 The regatta is open to all boats with a Handicap rating

3.2 Late entries will be accepted under the following conditions: Online registration and payment (cash only) on the date of the event.

3.3 The following restrictions apply: All boats must have functioning Navigation Lights and a VHF radio (on at all times).

4 FEES

5 THE SERIES

The regatta will consist of 3 events held in July, August and September on the Saturday closest to a Full Moon.

6 SCHEDULE

Registration: Open on June 25 2017

The scheduled time of the warning signal for the race each day/date is 7.30pm.

7 MEASUREMENTS

None required.

8 SAILING INSTRUCTIONS

The sailing instructions will be available after June 25 2017 on ArizonaYachtRacing.com

9 VENUE

Lake Pleasant, AZ.

10 THE COURSES

The courses to be sailed will be posted on ArizonaYachtRacing.com COURSE MAPS

11 PENALTY SYSTEM

The Scoring Penalty, rule 44.3, will apply.

Decisions of the protest committee will be final as provided in rule 70.5.

12 SCORING

The scoring system is as follows: 1 point for 1st, 2 for 2nd and so forth. A boat that did not *start*, did not *finish*, retired or was disqualified shall be scored points for the finishing place one more than the number of boats entered in that day's series race. ONE race is required to be completed to constitute a series.

13 SUPPORT BOATS

Support boats shall be marked with a flag and lights

14 RADIO COMMUNICATION

Since this SERIES is raced at night, radio communication between boats is encouraged and permitted. Use only Chanel VHF 68

15 PRIZES

Prizes will be given as follows: 1st Place 50% of fees paid, 2nd place 20%, 3rd place 10%

16 DISCLAIMER OF LIABILITY

Competitors participate in the SERIES entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

17 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of US\$100,000.00 per incident or the equivalent.
